- Senator Lima:

 - Thanks the Inspire Party Caucus for selecting Senator Lima to run to represent District D in this term.

 - Urges everyone to be responsible stewards of their positions.
 - Asks to defy the status quo, and question your leadership.

 - “Let’s raise the bar, senators.”
- Senator Bindi:
 - Senator representing college of liberal arts and sciences.
 - Previously served as the Inspire Caucus leader.
 - Over the summer, he had the privilege of holding a position of power.
 - Was given this opportunity because he was lucky.
 - Talks about a conversation with someone, who said that his leadership was a “mistake.”
 - High over turn over in senate led to positions being opened, allowing Senator Bindi to apply to leadership positions.

Senate President

- Senator Hernandez moves to open the floor to nominations.
- Senator Hernandez nominates Senator Dunson.
 - Senator Dunson accepts.
- Senator Lima nominates Senator Chou.
 - Senator Chou accepts.
- Senate Pro Tempore Dunson:
 - Wishes all the senators a good evening.
 - Congratulates new senators.
 - As one of the longest serving senators, can attest that this chamber will shape your heart, what advocacy means to you, and shape your college experience.
 - As Senate Pro-Tempore she has instilled programs and practices that bring the chamber together during a trying and dividing time in the chamber.
 - Committed to reshaping the culture that is focused on education, engagement, and advocacy.
 - Education: will include a procedural workshop that helps senators learn the UF Constitution, Senate Rules and Procedures, Robert’s Rules of Order and professional etiquette.
 - Will also be pairing with the CCC to help senators gain tools and gain experience of interviewing processes.

- As Senate President, wants to create more Ad-Hoc Committees, specifically regarding combating sexual assault. He would also like to have a 700 and 800 codes revision committee.
- He wants to bring more sexual awareness to the chamber.
- Five Minutes of Questions and Answers:
 - Senator Karim: You have been a relentless advocate for the student body. How do you intend to resolve animosity within the chamber?
 - Senator Chou: Wanted to do after Senate Socials. An example would be to get food with each other to gain comfort with each other.
 - Senator Nelson: If you lack such a belief that we can make a difference as senators how can we trust you to help us in the chamber?
 - Senator Chou: People do not often get things done. Wants to help people get to where they need to be to be in a position where they can enact change.
 - Senator Tio: Can you explain how as a Senate President you will help us make as many changes on campus as you have?
 - Senator Chou: I know how this university works and I want to share that with all of you so that each senator has the same opportunities that I had to make those changes.
 - Senator Ragan: Do you plan to use the \$10,000 line item provided by SG to help with live streaming?
 - Senator Chou: Does not think that money should necessarily be taken from that line item so long as it is being spent appropriately.
 - Senator Lima: We have seen a recent change in codes, would you spearhead movements to bring change to that?
 - Senator Chou: Would make sure that the codes are reviewed and revised as needed, to ensure a fair set of codes.
 - Senator Nimer: Could you talk about your experience with student organizations in the past?
 - Senator Chou: Has been contacting as many organizations as possible to make sure that students are informed about budget changes and how to walk through the budget cycle.

In a roll call vote of 43 to 36, Senate Pro Tempore Dunson has been elected Senate President. Chief Justice Walsh Swears in Senate President Dunson.

Senate President Pro-Tempore

- Senator Hernandez nominates Senator Sandifer.
 - Senator Sandifer Accepts.
- Senator Lima nominates Senator Jackson.

- Senator Jackson Accepts.
- Senator Lima closes the floor by unanimous consent. Approved.
- Senator Sandifer:
 - Congratulates the newly elected senators.
 - Confident that every senator here will do great work for all 50,000 students on our campus.
 - Excited to be running.
 - Through high school he, believed that student government just picked homecoming spirit days.
 - Perceptions on SG changed when coming to the University of Florida.
 - Joined a student financial group in the business school.
 - Won a senate seat, but wanted to help students in even larger capacities.
 - His sophomore year, he was on the Career Connections Center advisory committee.
 - Was appointed to the Capital Improvement Trust Fund Committee.
 - Having served as the Judiciary Chairman, has written many pieces of legislation to benefit the student body.
 - Thanks Senate President for showing him how to have a good connection with those in the chamber. Hopes to still have one on ones and meet all new senators.
 - Notes that the Senate does not currently table at the architecture school, for an example of how to increase outreach and bring in more senators.
 - Wants to upgrade the website to have more easily accessible information.
 - Hopes that the chambers allows him to move into this role as Pro-Tempore.
- Five Minutes of Question and Answer:
 - Senator Jones: What aspects of you currently being a senator will help you be a good Senate Pro-Tempore?
 - Senator Sandifer: My tenure in senate is one of the main factors. Wants to implement his own things after being with SG for so long. Wants interact with administration and outside entities, and has the experience to do so. Also wants to work with outreach to transfer and out of state students.
 - Senator Goren: You named a lot of ideas and things you want to do, is there a goal for that?
 - Senator Sandifer: Wants to continue the one-on-one program because it creates a community amongst the people in the chamber. Also wants to improve resources for senators, based on the SG website being down often. Finally wants to make information on committees much more accessible.
 - Senator Bindi: As Senate Pro Tempore, you will be chairing the Replacement and Agenda and it is important to have experience and knowledge on the governing documents, how will your experience help you do that well as chair of the committee?

- Senator Sandifer: As Judiciary Chair, we are working on constitutional documents on a daily basis to make sure legislation complies when passing it.
- Senator Girschick: How is being an out of state Gator going to help you bring new perspective?
- Senator Sandifer: Being an out of state student brings a totally different mindset.
- Senator Jackson:
 - Represents the College of Engineering.
 - One of the founders of the LGTBQ+ caucus in the chamber.
 - Has worked hard for senators to feel that they have a voice and space to be heard.
 - Was appointed to one committee, and has worked towards passing legislation to work on pressing campus initiatives.
 - When the recommendations for the Rules and Ethics Committee were sent back the R/A committee, Senator Jackson was not appointed for the next set of recommendations.
 - Will do everything in her power to work with justice to make sure no senator ever feels like she did.
 - Wants committees to be efficient and clear.
 - Have met with ample amounts of people, including speaking with administrators and forming caucuses, and have been able to reach conclusions that people can agree on.
 - Has worked with people who know the process and those who do not.
 - Has worked on codes to be less gender bias and help support LGBTQ+ community.
 - Wants to be part of the body that people can reach to.
- 5 Minutes of Question and Answer:
 - Senator Lima: As a senator how do you feel that you have actively worked those on the other side of the aisle in a bipartisan way?
 - Senator Jackson: Most proud of a 700 code revision that will allow those who don't identify with their name to use an alternative name on the ballot.
 - Senator Karim: The Replacement and Agenda committee often does not release the agenda until Monday, do you intend to make the committee more efficient so that we can get the agenda potentially earlier?
 - Senator Jackson: Would rather the agenda be sent out on Saturday rather than the day before the meeting.
 - Senator Hernandez: Based on walking out of the chamber, can you expand on your commitment to the senate because of these actions?
 - Senator Jackson: Cannot morally stand behind decisions that hurt students, which should speak to the commitment that Senator Jackson has to the chamber.
 - Senator Tio: Can you talk about how your past campus leadership experiences have prepared you to be Senate Pro-Tempore?

- Senator Jackson: Was the president of a campus organization where she had to prepare agendas and look after many similar tasks that senate pro tempore would have to. She also works for Gator Nights and is currently serving as a manager. As a manager she has learned to be unbiased, make schedules, and oversee others.
- Senator Kendrick: Do you plan on having oversight for committee chairs?
- Senator Jackson: Time expired.

- Senator Lima nominated Senator Solomon.
 - Senator Solomon accepts.
- Senator Brown moves to close the floor for nominations.
- Senator Rush:
 - Serves as a senator for the CLAS.
 - Congratulates new senators.
 - Excited to work with everyone.
 - Running as a member of student government.
 - Will uphold the Member at Large position to make sure that campus' best leaders are able to lead in the chamber.
 - One way she would personally describe herself as a leader.
 - Joined SG to serve as a voice regardless of political party.
 - Puts in the work for all students to feel included.
 - Currently serves in the Budget committee.
 - Received advice from past members on the R/A committee.
 - Coming as a replacement senator was intimidating but she will not stop working towards serving constituents and helping appoint qualified candidates.

- Senator Tio: Can you name a specific instance when you had to reach across the aisle to work on a common goal?
- Senator Rush: Has worked on legislation with Alfredo Ortiz.
- Senator Amrose: Will you promise to make sure that students are given 5 minutes to speak on their qualifications.
- Senator Rush: Yes, given everyone deserves a chance.
- Senator Jackson: Can you name a piece of legislation you have written or sponsored from across the aisle?

- Senator Solomon: We need transparency in the Replacement and Agenda Committee.
- Senator Diaz: Can you talk to me about a time you were bipartisan?
- Senator Solomon: Last spring, I worked on a resolution regarding the burning of the Notre Dame Cathedral in Paris, France with support and assistance from senators across the aisle, including former senator Sophia Bond.
- Senator Hernandez: Given you voted for your own party previously, do you think that you are contributing to this bipartisanship?
- Senator Solomon: Voted for the way he voted based on who he thought was the right candidate, and to “even the score.”
- Senator Tio: What do you think are the best qualifications for the R&A committee?
- Senator Solomon: States what Solomon looks for in a candidate for the Replacement and Agenda Committee.
- Senator Amrose: Will you promise to give candidates an adequate time of 5 minutes?

- Senator Hoffman:
 - Second year accounting major from Tampa, Florida.
 - Loves being a gator.
 - We are all bonded by the Gator Nation.
 - Ironically loves how large the university is, despite being scared of that before attending the University.
 - Feels that it has given her the opportunity to meet everyone on campus and his or her backgrounds.
 - It is inspiring to hear the stories that make up the student body.
 - Interviewed for a freshman seat in the fall, and has come a long way since then.
 - Loves this university with her whole heart and she wants to give back to it just as much as it has given to her.
 - Has worked with the Replacement and Agenda Committee in the past, which can equip her for the future.
 - Outside of senate, she serves on her sorority's judiciary committee, which has equipped her to be un-biased.
 - Currently serves as the Treasurer for her sorority, and being on the Executive Board of this sorority qualifies her to be on the R/A committee.
 - Strongly believes that her leadership positions have set her up well to be a member at large.
 - Wants to uplift other women in pursuit of their goals.
 - Wants to help women have a voice.
 - Wants to create more clarity during the interviewing process.
 - Creating awareness of the open seats is very important.
 - Although she did not get a seat when she first applied to an open seat, she learned a lot and gained a valuable experience.
 - Promises to remain devoted to the body, and that the committee selects the most qualified students on this campus.
- Five Minutes of Question and Answer:
 - Senator: How did time on your sorority's judiciary committee best prepare you for this position?
 - Senator Hoffman: It helped tremendously. Being objective in these decisions will equip Senator Hoffman to remain unbiased.
 - Senator Girschick: What are the specific qualifications that you would look for in a candidate who applies to seats?

- Senator Hoffman: Wants to look for those who are dedicated, and will go the extra mile for their constituents.
- Senator Garcia: How can we trust you to be bipartisan and represent both sides of the aisle?
- Senator Hoffman: It is very important to have an open mindset, and learn those in the chamber more than she already does, and will exhibit this through the Replacement and Agenda Committee.
- Senator Shaw: You talked about how you went through the process of being on the R&A committee, can you talk about that process, and what you would like to do with the committee based on that previous experience.
- Senator Hoffman: Even being able to interview as many time as herself, it gives Senator Hoffman a chance to work with those who diligently apply for Senate.
- Senator Bindi: In your presentation you claimed to be the clerk of the replacement & agenda committee, when did that happen?
- Senator Hoffman: It was when Senator Shaw was the Pro-Tempore so either the spring of the fall. It helped her learn a lot and get her foot in the door.
- Senator Jones: Can you talk about your experience on the executive board for your sorority?
- Senator Hoffman: Time expires.
- Senator Barocas:
 - Represents the CLAS.
 - Asks to be one of the Members at Large elected to the R/A Committee.
 - Previously was not considered during deliberations in an R&A meeting for a seat on the Budget and Appropriations Committee.
 - Felt this was disheartening.
 - Will not let this happen as a Member at Large.
 - Will ask thorough questions to make sure candidates are the right fit.
 - Wants to reflect the idea of “checking partisan affiliations at the door.”
- Five Minutes of Question and Answer:
 - Senator Lima: Given that everyone in committees is on the majority party, do you think that this is unfair?
 - Senator Barocas: This is unfair. Resumes and qualifications always take precedence over affiliation.
 - Senator Amrose: Do you promise to give at least 5 minutes of deliberation time for those applying through R/A?
 - Senator Barocas: Yes.
 - Senator Tio: Can you briefly explain how your past leadership experiences have equipped you for this position?
 - Senator Barocas: Gives his previous experiences that he feel qualifies him for the committee.

- Senator Hernandez: How do you plan on surrendering your bias to your party to remain un-biased during your time on this committee?
