STUDENT SENATE MINUTES June 9, 2020

The Senate President called the Senate meeting to order at 7:30 pm and announced that the meeting may be filmed or audio recorded and may be available to the public. The Pledge of Allegiance was recited.

PUBLIC COMMENT:

- Pro-Tempore Cooper Brown Greets Senators, shares thoughts on recent events affecting our community. Made statement about events that happened during the judiciary meeting. Encourages white senators be better allies to the black community. Spoke about pending resolution.
- Chairman Seth Longland Spoke about comments made at the judiciary meeting. Encourages resolution be tabled back to the committee.
- Senator Ryan Wilder Spoke against Branden Pearson, asked to strike him from the agenda and shared homophobic remarks that he has made.
 A request was made to have the minutes reflect the following quote said during remarks: "Branden Pearson called a member of the UF community a faggot and during my remarks Branden Pearson moved to adjourn the June 18th senate meeting prior to the review of two pro LGBTQ+ pieces of legislation."
- Senator Claudia Tio Apologized to the student body for SG failing to impeach former Student Body President, Michael Murphy. Audio inaudable.
- Senator Colin Solomon Speaks against Branden Pearson being appointed as Internal Affairs Director
- Senator Bruce Glasserman Introduces self to Senate, spoke against homophobia, believes it is the job of the Senate to represent every student no matter what, asked for people to contact him if interested in working on his resolution
- Senator Faith Allen Spoke on Digital Racism resolution. Made statement against racism to Senate. Urges Senate vote to send resolution back to the committee.
- Senator Tyler Kendrick Made statement against racism to Senate. Spoke about resolution being created to take a stand against racism urged anyone interested to help.
- Senator Marcus Nelson Made statement against racism to Senate

- Senator Wynton White Acknowledges recent victims of police brutality. Thanks Trevor Pope and Pro Tempore Brown for using platform to make positive changes. Thanked Branden Pearson for being an ally towards the black community. Spoke about digital racism bill. Made statement against racism to Senate. Encourages Senate to pass legislation. Encourages Senate President to create a diversity committee.
- Senator Zachery Utt Introduces self to senate. Made statement against racism. Spoke about racism problem at UF. Urges senate to pass resolution
- Senator Sydney White Greet Senate, introduces self, addresses comments made during
 judiciary committee meeting. Spoke on why she voted to remove Liberty Woodly's name
 from bill. Wants bill to be re-written to reflect recent changes. Spoke about resolution
 being written to commend UF's decision receding Liberty's acceptance to UF invited
 people to help if interested.
- Senator Sahil Patel Greets Senate, speaks on two amendments he and Senator Utt made on bill 2020-1032.
- Senator Zachariah Chou Spoke against Branden Pearson. Responded to comment Senator White
- Minority Party Leader Shawn Zimmer Urges senate to listen to concerns that are brought up about racism and homophobia
