STUDENT SENATE BILL 2020-1062

TITLE: Resolution Supporting the Creation of a First-Generation Living Learning Community in the Murphree Area

WHEREAS, the Department of Education defines a first-generation student as: an individual, neither of whose parents completed a baccalaureate degree or an individual who, prior to the age of 18, regularly resided with and received support from only one parent and whose supporting parent did not complete a baccalaureate degree or an individual who, prior to the age of 18, did not regularly reside with or receive support from a natural or adoptive parent [1]; and,

WHEREAS, 56% of undergraduates nationally are first-generation students [2]; and,

WHEREAS, nationally, 41% of African-American students and 61% of Latinx students belong to this demographic. These numbers constitute the statistic that most first-generation students come from underrepresented minorities and are therefore subject to a higher degree of difficulty in transferring into the college environment [3]; and,

WHEREAS, 90% of low-income first-generation students do not graduate on time due to a lack of academic community which provides influential relationships that lead to a support system of mentors with shared experiences [4]; and,

WHEREAS, around to 20%-22% of undergraduate students at the University of Florida are first-generation students, which approximates 7000-8000 students [5]; and,

WHEREAS, a Living Learning Community gives students access to programs, speakers, and activities that are designed to support the interests and needs of students in a focused area, allowing those students to build a sense of community which serves as a pillar in academic success [6]; and,

WHEREAS, the PROMISE program at the University of Florida offers first-generation students the privileges of a Living Learning Community only in the Summer B term in the Murphree Area [7]; and,

WHEREAS, other living learning communities have been created for underrepresented students like the Black Living Learning Community in Graham Hall [8]; and,

WHEREAS, in the state of Florida, the only university that permanently implemented a first-generation Living Learning Community is the University of Central Florida. Additionally, other universities across the nation have also implemented similar housing communities for first-generation students, such as the University of Iowa, the University of Michigan, and the University of Louisville. Thus, Living Learning Communities make their campus a more welcoming environment for first-generation students [9]; and,

WHEREAS, the University of Florida does not have a year-long first-generation Living Learning Community; and

THEREFORE, LET IT BE RESOLVED that the University of Florida Student Government Senate recognizes the need for the University of Florida's Housing Department to create a Living Learning Community for First-Generation Students in the Fall and Spring semesters in the Murphree Area.
