

**STUDENT SENATE BILL 2021-1004**

**TITLE: Resolution requesting that the State of Florida review Pedestrian Safety Measures in and around the University of Florida Campus**

**WHEREAS**, on December 9th, 2020, Maggie Paxton, a freshman year University of Florida student was killed in a hit and run and on January 16th, 2021, a car accident killed Sophia Lambert and injured five others [1]; and,

**WHEREAS**, in the aftermath of Sophia Lambert's death, there has been an outcry from the UF student body for pedestrian traffic safety changes; and,

**WHEREAS**, members of the community have proposed ideas to lower the speed limit, put up barriers between the sidewalk and the road, add more lighting, and install more cameras; and,

**WHEREAS**, West University Avenue, a stretch of State Road 26, is a state-owned and maintained road frequently traveled by vehicles and pedestrians alike with a speed limit of 35 miles per hour; and,

**WHEREAS**, all crosswalks throughout and around campus should be evaluated to ensure better safety for pedestrians and University of Florida students, along with residents of Gainesville and university faculty; and,

**WHEREAS**, the risk of fatality on foot in the State of Florida is significantly higher than any other state [2]; then,

**THEREFORE, LET IT BE RESOLVED**, that the University of Florida Student Senate recognizes the need to implement changes along all crosswalks surrounding the University of Florida to ensure the safety of all students.

**THEREFORE, LET IT FURTHER BE RESOLVED**, that the University of Florida Student Senate supports the efforts of UFPD in combating the issues of traffic safety with their Gator Special Traffic Enforcement Program (STEP).

**THEREFORE, LET IT FINALLY BE RESOLVED**, that the University of Florida Student Senate encourages the City of Gainesville, Florida Department of Transportation, and the State of Florida to act swiftly to implement additional changes that ensure the safety of students and Gainesville citizens.
