## STUDENT SENATE BILL 2023-1162

TITLE: Resolution Requesting Student Legal Services to Assist Students with Immigration Services

**WHEREAS**, the University of Florida serves a significant population of international students who contribute to the intellectual and cultural diversity of the campus [1]; and,

**WHEREAS**, international students often face complex and challenging immigration processes, requiring expert legal assistance to navigate [2]; and,

**WHEREAS**, legal assistance in immigration matters is often expensive and may be inaccessible to students, hindering their educational pursuits and potential contributions to the university community [3]; and,

**WHEREAS**, other universities, such as Emory University, have recognized the importance of providing legal support to international students, establishing initiatives to ensure proper immigration assistance [4]; and,

WHEREAS, such assistance would directly support international students, helping them maintain legal status in the United States and ensuring their ability to continue and effectively focus on their studies; and,

WHEREAS, international students are vital to improving the university's reputation globally in order to promote greater representation of individuals from all cultures and backgrounds; then,

**THEREFORE, LET IT BE RESOLVED** that the University of Florida Student Senate recognizes the importance of providing immigration legal support as a fundamental service for the success of international students.

**THEREFORE, LET IT FURTHER BE RESOLVED** that the University of Florida Student Senate recognizes the necessity of expanding Student Legal Services to include immigration assistance, in line with best practices across higher education institutions.

**THEREFORE, LET IT FINALLY BE RESOLVED** that the University of Florida Student Senate calls upon Student Legal Services to develop and implement a program to assist students with immigration services, aligning with the university's commitment to inclusivity, diversity, and student success.
