On September 19th, 2019, at approximately 1:41 PM, Gator Party member Audrey Wikan posted campaign material—an Instagram story, specifically—that we do not believe was registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post included the text "I cannot stress this enough... HASHTAG. IT. STARTS. WITH. YOU.", which is a slogan of Gator Party, and "@gatorpartyuf", and also included Gator Party's platform over an orange background. The post is campaign material per §760.4(f).

§762.0 states "Candidates shall ensure that all "campaign material" as defined in Section 700.4(f) shall be labeled with the phrase "Registered Political Advertisement" or a phrase of similar import approved by the Supervisor of Elections. The phrase shall be followed by the name of the individual who authorized the creation of, disbursement of, or payment for, a piece of campaign material. In addition, all campaign material must be registered with the Supervisor of Elections or his or her Assistant Supervisors of Elections prior to the time of distribution. Procedures for distribution and posting of campaign material not provided for by the Student Government Election Code may be established by the Supervisor of Elections or by the Elections Commission. However, such procedures shall not be inconsistent with the Student Government Election Code and they shall not be effective unless presented in writing to the candidates and registered political parties twenty-four (24) hours prior to the time that any such procedures take effect."

§700.4(f) states "(f) "Campaign Material" means any print or electronic material used for the purpose of supporting a candidate or political party for an elective Student Body office, an initiative, a referendum question or proposed constitutional amendment. "Campaign material" shall include, but not be limited to, fliers, banners, posters, placards, electronic mail internet posts, and clothing".

Therefore, Gator Party member Audrey Wikan seemingly committed a violation of §762.0, as she seemingly did not get this exact campaign material properly registered before she submitted it.

Describe what happened (be specific - include time and dates):

On September 23rd, 2019, at approximately 2:26 PM, Gator Party candidate Marcus Nelson tabled outside Beaty Towers in a manner which was out of compliance with SAI policies.

Specifically, the video shows the candidate waiting for students to pass by to campaign to them on behalf of Gator Party.

§765.1 states "Campaign materials accompanying tables permitted pursuant to 765.0 may include a banner not to exceed 4' X 4'. Any banner under this section may be displayed in a manner that the total height does not exceed 12'. The supporting mechanism for such banner may not exceed 2" X 2" in girth. Campaign materials may be displayed on or around any table permitted pursuant to 765.0 in any manner subject to University guidelines and the other provisions of this chapter."

§746.0 states "All political parties must comply with all rules and regulations governing student organizations set forth by the Department of Student Activities and Involvement."

Thus, Gator Party is prohibited from tabling without a permit from SAI, as SAI states within its policies that "Tabling requires a permit submitted in Gator Connect by a member of the student organization." Because no such permit was submitted by Gator Party to table at Beaty Towers with their own table, Gator Party and candidate Marcus Nelson are not in compliance with §765.1 and §746.0.

On September 24, 2019, at approximately 8:52am, Gator Party was seen tabling in the Reitz Union Outdoor Tabling Area, an area that was not reserved for the purpose of Student Government election tabling. This is a violation of a Student Activities and Involvement regulation which states that "All student organization events or programs (excluding general organization meetings), that take place on University grounds, require an Event Permit obtained by completing a request through Gator Connect."

The J. Wayne Reitz Union Event Services Confirmation dated September 16, 2019 demonstrates that tabling was only allowed at the North Terrace on that day. Gator Party's tabling at the North Terrace constitutes a violation of §746.0, which states that §746.0 states that "All political parties must comply with all rules and regulations governing student organizations set forth by the Department of Student Activities and Involvement."

The relevant regulation stating that "All student organization events or programs (excluding general organization meetings), that take place on University grounds, require an Event Permit obtained by completing a request through Gator Connect." can be found at https://www.studentinvolvement.ufl.edu/Event-Planning/Event-Policies.

On September 18th, 2019, at approximately 7:20 PM, Gator Party supporter Julia Rodriguez posted campaign material—an Instagram story, specifically—that was not registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post showed Gator Party campaign material and included the text ""Go gator party !!!!". Describe what happened (be specific - include time and dates):

The identity of Gator Party's true president has been a subject of widespread intrigue, including from the Independent Florida Alligator ("the Alligator"). According to the Alligator, "[o]n Aug. 27, the [Gator] party submitted a Letter to the Editor to The Alligator announcing its establishment at 7:24 p.m. The letter named Dunson as president, Wynton White as spokesperson and Doan as treasurer... Stephanie Siler, the SG supervisor of elections, received an updated registration for Gator Party on Aug. 27 with Doan as the party's treasurer, she wrote in an email. She said she received an email from Grosse that same day at 7:33 p.m. stating Dunson would serve as Gator Party's president. The party's Facebook announcement on Aug. 28 and all subsequent campaign materials refer to Dunson as president."

§762.11 states that "No candidate or representative of a political party shall misrepresent any material fact in campaign material or in campaigning in any form."

Danielle Grosse was Gator Party's president at the time that the Alligator was fold that Emily Dunson was Gator Party's president. Thus, Gator Party misrepresented a material fact—the identity of its party president, a clear violation of §762.11.

Gator Party has attempted to change its party president or treasurer through submitting multiple party registration forms and through email to the Supervisor of Elections.

Further, however, there is no process within the election laws to change a party's president through email. The only statutory process to name a party president is that encapsulated within §741.0, copied below.

741.0

The official registration of a political party shall be fulfilled by the procedures herein defined. All prospective political parties and political parties shall physically file conditions (a) through (e) with the Supervisor of Elections or his/her designee at the Student Government office no sooner than 9:00 AM seven (7) calendar days prior to the first day of qualifying and no later than noon of the day immediately prior to the first day of qualifications as specified in 733.0 all of the following information which shall be certified as correct by the party president:

- (a) Name of party;
- (b) Name, address, classification, student number, email address, and telephone number of the party president;
- (c) Name, address, classification, student number, email address, and telephone number of the party treasurer;
- (d) Address and telephone number of any party headquarters;
- (e) Name, address, classification, student number, email address, and telephone number of a designated party representative if different than the named party president.

Of further relevance is §741.0, as it contains a process for a change in leadership accessible to the party president of a party which used that name in a previous campaign.

741.1 When registering political parties the name of the party may be retained by the students who used that name in the previous election. The president (and only the president) of the party from the previous semester has the right of first refusal to the party name if the party ran one (1) campaign in the last three (3) election cycles. If the president does not want to use the name again, the name may be used by the group that submits the first complete registration. The registration includes a hard copy of the political party registration.

Gator Party has not ran candidates in a previous campaign in the last three (3) election cycles.

There is no process in §741.0 or §741.1 to allow a party to submit multiple registration forms to update its leadership.

There is no statutory process which enables Gator Party to change its party president—in email or otherwise—during a campaign, while codes relevant to selecting a party president specify a process incompatible with Gator Party's attempts to change its leadership.

Each instance of Gator Party referring to Emily Dunson in social media or otherwise as the party president is thus a misrepresentation of material fact, as only the original party registration is valid.

Even if Gator Party's solution of naming Emily Dunson as party president through email was valid, the fact that Gator Party apparently sent this email to the Supervisor of Elections naming Dunson as the party president only after telling the Alligator that Dunson is party president is a misrepresentation of material fact.

On September 25th, 2019, at approximately 2:30 AM, Gator Party candidate Feraby Hoffman maintained campaign material—an Instagram story, specifically—that we do not believe was registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post showed imagery of Gator Party campaign material and included the text ""go gator party!!" and "vote today!!!!!". The post is campaign material per §700.4(f), as it is "electronic material used for the purpose of supporting a candidate or political party for an elective Student Body office." In this case, the material was used for the purpose of supporting Hoffman and Gator Party. Therefore, we believe that Hoffman violated §762.0.

§762.0 states "Candidates shall ensure that all "campaign material" as defined in Section 700.4(f) shall be labeled with the phrase "Registered Political Advertisement" or a phrase of similar import approved by the Supervisor of Elections. The phrase shall be followed by the name of the individual who authorized the creation of, disbursement of, or payment for, a piece of campaign material. In addition, all campaign material must be registered with the Supervisor of Elections or his or her Assistant Supervisors of Elections prior to the time of distribution. Procedures for distribution and posting of campaign material not provided for by the Student Government Election Code may be established by the Supervisor of Elections or by the Elections Commission. However, such procedures shall not be inconsistent with the Student Government Election Code and they shall not be effective unless presented in writing to the candidates and registered political parties twenty-four (24) hours prior to the time that any such procedures take effect."

On 9/24/19, at approximately 11:00 AM, Jeffrey Fondeur posted campaign material—an Instagram story, specifically—that we do not believe was registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post showed Gator Party platform cards and an I Voted sticker in someone's hands in the immediate vicinity of a voting location (as indicated by the 'VOTE HERE' sign in the background of the photograph) and included the text "I Voted" and "@gatorpartyut" and indicates that the photo was taken near the Springs Complex, which includes a voting location. The post is campaign material per §700.4(f), as it contains imagery of Gator Party platform cards in the immediate vicinity of a voting location accompanied by text indicating support for Gator Party.

§762.0 states "Candidates shall ensure that all "campaign material" as defined in Section 700.4(f) shall be labeled with the phrase "Registered Political Advertisement" or a phrase of similar import approved by the Supervisor of Elections. The phrase shall be followed by the name of the individual who authorized the creation of, disbursement of, or payment for, a piece of campaign material. In addition, all campaign material must be registered with the Supervisor of Elections or his or her Assistant Supervisors of Elections prior to the time of distribution. Procedures for distribution and posting of campaign material not provided for by the Student Government Election Code may be established by the Supervisor of Elections or by the Elections Commission. However, such procedures shall not be inconsistent with the Student Government Election Code and they shall not be effective unless presented in writing to the candidates and registered political parties twenty-four (24) hours prior to the time that any such procedures take effect."

§700.4(f) states "(f) "Campaign Material" means any print or electronic material used for the purpose of supporting a candidate or political party for an elective Student Body office, an initiative, a referendum question or proposed constitutional amendment. "Campaign material" shall include, but not be limited to, fliers, banners, posters, placards, electronic mail internet posts, and clothing".

Therefore, Jeffrey Fondeur committed a violation of §762.0 by failing to properly register a campaign material (an Instagram story post) before distributing it.

On September 25th, 2019, at approximately 1:23 AM, Gator Party candidate Aarin Kim posted campaign material—an Instagram story, specifically—that we do not believe was registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post included the text "Hey guys don't forget to vote!!!" and "@GATORPARTYUF", and also included a poll for which options are "DONE IT!! [happy face emjoi] [happy face emjoi]" and "WORK IN PROGRESS". The post is campaign material per §700.4(f), as it contains text of support for voting for Gator Party candidates.

Specifically, the post showed the Gator Party platform and included the text "Which do you resonate with??", "Change is coming", and the Gator Party Instagram account name. On September 25th, 2019, at approximately 2:21 AM, Gator Party candidate Jeffrey Fondeur posted campaign material—an Instagram story, specifically—that we do not believe was registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post included a graphic of the Gator Party logo, and the text "Voting day is finally here!!", "Poils close at 8:30 PM", and "At the polls". The post is campaign material per §700.4(f), as it contains imagery and text that comprises "electronic material used for the purpose of supporting a candidate or political party for an elective Student Body office". Therefore, we believe that Fondeur violated §762.0 by failing to ensure that the material was "registered with the Supervisor of Elections or his or her Assistant Supervisors of Elections prior to the time of distribution".

At approximately 4:15 PM on 9/25/19, Gator Party's supposed president and fellow Gator Party candidates Lindsay Kaighin and Jeff Fondeur walked with several students to the voting location at the Springs Complex Area Office, campaigning well within the statutorily proscribed fifty feet of the voting location (see timestamp 1:30). These candidates are recorded with campaign materials in hand clearly within fifty feet of the voting location (see timestamp 2:10).

Jeff Fondeur had earlier included text in an instagram story he posted indicating that he had already voted.

§763.5 states that "No campaigning shall take place within fifty (50) feet of the door of any polling location or within 50 feet of any queue of voters defined in 700.4 (z) waiting to vote, with the exception of the designated outdoor tabling space at the J. Wayne Reitz Union."

Therefore, Gator Party candidates Emily Dunson, Lindsay Kaighin, and Jeff Fondeur each committed a violation of §763.5, as they are recorded campaigning within fifty feet of the door of the Springs Complex Area Office voting location as they spoke with students and left them at the voting location.







On September 24th, 2019, at approximately 9:40 AM, Gator Party Broward-Rawlings candidate Olivia Potthast campaigned within fifty (50) feet of the door to the Broward Hall - Broward Rec Room voting location.

§763.5 states "No campaigning shall take place within fifty (50) feet of the door of any polling location or within 50 feet of any queue of voters defined in 700.4 (z) waiting to vote, with the exception of the designated outdoor tabling space at the J. Wayne Reitz Union."

Video evidence demonstrates that Potthast walked a potential voter directly to the entrance that leads to the voting location. Pursuant to §700.4(d), Potthast's act of walking the potential voter to the entrance to the building containing the voter location is campaigning, this is an "intentional action in support of, or in opposition to, a candidate or political party for an elective student body office". Therefore, a violation of §763.5 occurred.





On September 17th, 2019, at approximately 3:41 PM, Gator Party candidates Meryl Jones and Marcus Nelson tabled outside Beaty Towers in a manner which was out of compliance with SAI policies.

Specifically, the video shows the two candidates waiting for students to pass by to campaign to them on behalf of Gator Party.

§765.1 states "Campaign materials accompanying tables permitted pursuant to 765.0 may include a banner not to exceed 4' X 4'. Any banner under this section may be displayed in a manner that the total height does not exceed 12'. The supporting mechanism for such banner may not exceed 2" X 2" in girth. Campaign materials may be displayed on or around any table permitted pursuant to 765.0 in any manner subject to University guidelines and the other provisions of this chapter."

§746.0 states "All political parties must comply with all rules and regulations governing student organizations set forth by the Department of Student Activities and Involvement."

Thus, Gator Party is prohibited from tabling without a permit from SAI, as SAI states within its policies that "Tabling requires a permit submitted in Gator Connect by a member of the student organization." Because no such permit was submitted by Gator Party to table at Beaty Towers with their own table, Gator Party and candidates Meryl Jones and Marcus Nelson are not in compliance with §765.1 and §746.0.

On September 25th, 2019, at approximately 2:31 AM, Gator Party member Audrey Wikan maintained a "story" on Instagram showing images of three Gator Party candidates: Madeleine Bennett, Olivia Botthast, and Kylie Grant. The story included the text "So excited to welcome you guys into the Senate chamber!!!" and "Chi Omega supports Madeleine Olivia & Kylie!". The photo is campaign material per §700.4(f), as it contains images of three Gator Party candidates, expressions of support for them, and is an "electronic material used for the purpose of supporting a candidate or political party for an elective Student Body office". The photo did not include the phrase "Registered Political Advertisement" or a phrase of similar import approved by the Supervisor of Elections, as required by §762.0. Therefore, Wikan violated §762.0.

On September 19th, 2019, at approximately 5:41 PM, Gator Party candidate Mary Faas posted campaign material—an Instagram story, specifically—that was not registered with the Supervisor of Elections or their Assistant Supervisors of Elections prior to the time of distribution.

Specifically, the post showed Mary with a sculpture and included the text "SEPTEMBER 24th and 25!!" and "Vote for Mary My favorite roomie/". Though Gator Party has procured party shirts since at least 9/9/19 at 10:08 AM, as documented in evidence provided below, Gator Party has not yet disclosed a financial report which acknowledges these shirts, thus breaking several election laws relevant to financial practices.

§751.0, §751.1, §751.2, and §751.3, inter alia, establish that political parties must report all their contributions and expenditures by statutory deadlines, and further establish that failure of a party to report all their contributions and expenditures by statutory deadlines "shall be guilty of a violation of these Election Codes and be subject to penalty pursuant to 728.2."

§751.0 states, in part, that "Each political party, or candidate, if running as an independent, shall submit to the Supervisor of Elections each Monday by 5:00 P.M. starting after the mandatory meeting referenced in 713.5 until the Monday following the election, as well as the Tuesday, Wednesday, and Thursday of election week, a statement of all contributions and expenditures. A copy of all bills received or paid by the political party or on the political party's behalf as of noon on that same day shall accompany this statement."

§751.1 states that "All political parties and independent candidates must submit financial reports on time even if no funds were raised or spent during that reporting period."

§751.3 states that "If the Elections Commission finds that a political party or independent candidate failed to file a financial report pursuant to 751.0, or filed a late financial report, the party or candidate shall be guilty of a violation of these Election Codes and be subject to penalty pursuant to 728.2."

Gator Party did not report any contributions or expenditures specific to procuring any of their many shirts in the financial report they submitted on 9/9/19, which should have included a statement of all contributions and expenditures during that reporting period ending at noon on 9/9/19. Gator Party members are recorded in Gator Party shirts at 10:08 AM on 9/9/19. Based off indications from previous semesters, the cost of these shirts can be reasonably believed to be substantial. Because the Gator Party has failed to report their expenditures and/or contributions specific to these shirts by the required reporting time of 5:00 PM on 9/9/19.

Describe what happened (be specific - include time and dates):

On July 9, 2019, The Independent Florida Alligator published a Letter to the Editor by current Gator Party member Brandon Pearson. In the letter, Pearson states that "Under former senators Grabwoski's leadership, the Inspire Party has categorically failed to make any meaningful change, short of passing a handful of non-binding resolutions." This statement is clearly fits the definition of "Campaign Activity" and therefore "Campaigning", as it is an "intentional action in support of, or in opposition to, a candidate or political party for an elective student body office" pursuant to 700.4 (d).

By publishing these attacks on the Inspire Party's leadership under Ashley Grabowski on July 9, 2019, a date which was not during an active election cycle, Pearson violated 761.1.

761.1 states that "Campaign Activities begin on the first day of the active election cycle and ends immediately after the close of polls on the final day of elections."

700.4 (d) states that "Campaigning" means any intentional action in support of, or in opposition to, a candidate or political party for an elective student body office, including, but not limited to the distribution of literature and posting of election specific materials. "Campaigning" does not include maintaining a website excluded to providing general information about the party and party members, or wearing campaign material, as defined in 700.4(f), a campaign shirt, a button, an emblem or similar paraphernalia, unless accompanied by the dissemination of campaign literature or the delivery of a campaign speech to solicit support for a candidate or political party.

700.4 (e) states that "Campaign Activity" will be interpreted as interchangeable with "Campaigning" and will be interpreted as having the full meaning ascribed in § 700.4(d) as per 2013-SC: Students Party v. Swamp Party decision.

Describe what happened (be specific - include time and dates):

On September 25th, 2019 at approximately 1:14 PM, Gator Party members walked into the Reitz Union with potential voters, talking with them about the elections, and went down the elevator together towards the voting location at the SG Print Lab in the lower level of the Union. They were within the Reitz Union--clearly within 50 feet of the voting location there, in violation of §763.5.

§763.5 states that "No campaigning shall take place within fifty (50) feet of the door of any polling location or within 50 feet of any queue of voters defined in 700.4 (z) waiting to vote, with the exception of the designated outdoor tabling space at the J. Wayne Reitz Union."

Therefore, many Gator Party members who were present each committed a serious campaign violation, as they walked a relatively large group of voters toward a voting location when they were will within fifty feet of that voting location, engaging in prohibited campaigning.

SAI policy specifically states:
