TITLE: Resolution Requesting the J. Wayne Reitz Union Board of Managers Establish a Bar within the J. Wayne Reitz Union

WHEREAS, the University of Florida Business Affairs Policy 4-001 § 4 (a) promulgates the authority of the J. Wayne Reitz Union Board of Managers to approve venue permits for the sale of alcoholic beverages within the J. Wayne Reitz Union [1]; and,

WHEREAS, there exists a need for further convenience in socializing, networking, and gatherings over food and beverage, particularly among alumni, faculty, staff, and students above the legal age minimum for alcohol consumption; and,

WHEREAS, in February 2023, Florida State University opened a Proof Brewing Company location in its on-campus Student Union, providing members of the university's community the chance to socialize over food and beverage [2]; and,

WHEREAS, peer institutions across the United States, including Brown University [3], Loyola Marymount University [4], the University of Texas at Austin [5], and Massachusetts Institute of Technology [6], among others, each have established bars within their respective Student Unions; and,

WHEREAS, the establishment of a bar within the J. Wayne Reitz Union would provide additional revenue for the union; and,

WHEREAS, the establishment of a bar within the J. Wayne Reitz Union would provide further work opportunities for students, particularly graduate students, who struggle to find adequate work on campus; now,

THEREFORE, LET IT BE RESOLVED that the University of Florida Student Senate requests the J. Wayne Reitz Board of Managers to open a bar within the J. Wayne Reitz Union for the reasons expressed herein.
