

**STUDENT SENATE BILL 2024-1164**

**TITLE: Resolution Urging the Creation of a Naloxone Distribution and Education Program on Campus**

**WHEREAS**, there were over 107,000 drug overdose deaths in 2021, with opioids being involved in 68% of them [1]. Additionally, Florida had the second highest number of drug overdoses of any state [2]; and,

**WHEREAS**, studies have shown Naloxone distribution among the public can reduce opioid overdose deaths by more than 20% [3]; and,

**WHEREAS**, the University of Florida Health already has a free Naloxone distribution program at locations around greater Gainesville, which does not include locations on or in close proximity to campus. The University of Florida as a whole has fallen behind other similar institutions, such as The University of Central Florida and Florida State University; and,

**WHEREAS**, in response to the opioid epidemic, Health Street distributed Naloxone to the Gainesville community, supplied by the Florida Department of Children and Families [4]. This initiative was well received by students at the University of Florida, which was evident due to the numerous times Health Street returned to distribute the product; and,

**WHEREAS**, the establishment of a free Naloxone distribution and education program could save the lives of students and reduce the effects of the opioid epidemic on members of the University of Florida community; and,

**WHEREAS**, Naloxone is safe, effective, and easy to administer. Free distribution would help eliminate any stigma surrounding the drug, making students more likely to have it on hand and be in a situation to use it if necessary. But, the current Naloxone availability, which costs \$25 per dose, is not sufficient; and,

**WHEREAS**, There has been a collaborative effort by students and university employees within various organizations to create more widespread access to Narcan and opioid education; and,

**THEREFORE, LET IT BE RESOLVED** that the University of Florida Student Senate recognizes the need for the distribution of free Naloxone and greater educational materials surrounding the subject of opioids and opioid overdoses.

**THEREFORE, LET IT FURTHER BE RESOLVED** that the University of Florida Student Senate urges the university administration to protect the health and safety of the student body and allocate sources to a Naloxone program, which will do so.

**THEREFORE, LET IT FINALLY BE RESOLVED** that the University of Florida Student Senate calls upon the administration to collaborate with GatorWell, Health Street, and the Student Health Care Center to create and implement a Naloxone distribution program that primarily serves students.


