WHEREAS, the climate crisis is a defining challenge of the twenty-first century. The United Nations Intergovernmental Panel on Climate Change (IPCC) issued a report in 2018 urging the necessity to reduce global emissions by 45% by 2030 (from 2010 levels) to prevent the worst consequences of climate change [1]; and,

WHEREAS, the state of Florida is especially vulnerable to the impacts of climate change. According to the Environmental Protection Agency, "In the coming decades, rising temperatures are likely to increase storm damages, harm coral reefs, increase the frequency of unpleasantly hot days, and reduce the risk of freezing to Florida's agriculture" [2]; and,

WHEREAS, as a leader in climate science, the University of Florida has a responsibility to model the types of climate policy that institutions around the world should be adopting; and,

WHEREAS, the University of Florida is a proud top public university [3]; and,

WHEREAS, the University of Florida lost their top five spot on the U.S News ranking in 2023 [4]; and,

WHEREAS, every university in the top ten ranking from U.S News has an updated climate action plan except the University of Florida [5-12]; and,

WHEREAS, In 2006, former UF president Bernie Machen acknowledged the urgency demanded by the impending climate crisis, and as such committed UF to become a leader in sustainability and mitigation efforts; and,

WHEREAS, Machen's proposal, the UF Climate Action Plan (CAP), and its more recent successor, CAP 2.0, have stalled in the wake of Ben Sasses' inauguration as UF President [13]; and,

THEREFORE, LET IT BE RESOLVED that the University of Florida Student Senate recognizes the urgent need for the adoption of the Climate Action Plan 2.0; and,

THEREFORE, LET IT FURTHER BE RESOLVED that the University of Florida Student Senate recognizes the adoption of the Climate Action Plan 2.0 as a guiding pillar of a Green New Deal for the University of Florida which it endorses the implementation of; and,

THEREFORE, LET IT FINALLY BE RESOLVED that the University of Florida Student Senate calls upon Florida legislators and higher education institutions to take action to address the climate crisis in an urgent manner.
