Khan moves to approve FY 25 Budget for 6 million by unanimous consent. Motion passes.

Quattrocchi asks what Community Engagement is replacing.

Dr. Tyger clarifies that Student Activities will cease to exist. Campus Events are going into Campus Engagement.

Quattrocchi moves to approve the FY 25 budget for Student Engagement in the amount of \$3 million by unanimous consent. Motion passes.

Quattrocchi moves to add a proviso stating: "This Appropriations Budget replaces the Student Activities and Involvement, Sorority and Fraternity Life, and Student Government budgets to reflect amended Student Engagement and Student Government budget lines that were included in SSB 2023-1115 Funding for Fiscal Year 2024-2025 Activity and Service Fee Budget." Motion passes.

Chairman Rodriquez calls for a recess until called back by the chair at 4:29 PM.

Quorum is established with 9 members present.

Chairman Rodriguez suggests a 0% increase due to impact on tuition. Invites input from Dr. Tyger.

Dr. Tyger states that the minimum wage increases in Florida to \$15/hr has had a significant impact. College affordability is a big priority in the state government. No appetite for increasing

the cost of attendance from the Board of Trustees and the Board of Governors. This will not change this year. Fee increases are unlikely. Hard choices will have to be made.

Senator Quattrocchi asks if it is out of our range for us to convince the state to raise tuition.

Dr. Tyger explains that tuition is set by the state. The fees are what the students can decide. If tuition is increased without Bright Futures being increased, it will have a collateral impact across state institutions. Budget cuts to finance other programs might be an alternative. Students want different things, and not all students use the same services. Cutting funds from ACCENT and SGP is not enough. Laying people off is also an alternative.

Khan asks what the process for approval is.

Dr. Tyger says it was passed in the Student Government and the Vice-President for Student Life, but it was ultimately rejected past that stage.

Chairman Rodriguez asks what the administrative strain of increasing by a certain percentage is.

Dr. Tyger explains that not all committees increase fees. Strategize ways that we can do things. Where are the priorities? I would probably put in a 0% for Student Engagement. I feel confident that this is not the year for the fee increase... It is a fee increase.

Chairman Rodriguez asks if there are any more questions.

Foyet asks if a fee increase in the middle is possible. Like 2%.

Dr. Tyger says yes.

Senator Boullosa asks a clarifying question on increases.

Dr. Tyger explains that any increase is unlikely. Even if it is a .1% increase. Many pros for the university.

Chairman Rodriguez states that tuition and fees have been clarified as steep for out of state students. Would like to proceed with a 0% increase.

Quattrocchi moves for the percentage increase for the call for increase to be 0% by unanimous consent. Motion passes.

Chairman Rodriguez talks about the funding for the Chinese Students and Scholars Association. Issue is we approved them for around \$2,000, which is not consistent with the code maximum (\$300). We will amend the total to \$300 and strike the breakdowns and totals, then amend the programs total to three hundred, and then the reasoning.

Quattrocchi moves to strike all event totals by unanimous consent. Motion passes.

Quattrocchi moves to amend amount approved to \$300 by unanimous consent. Motion passes.

Chairman Rodriguez announces new totals for organizations.

Sarkar moves to amend the total amount approved for SAKES to be \$1779.91, the total amount approved for the Bangladeshi Student Association (BSA) to be \$137.053, the total amount approved for Filipino Student Association (FSA) to be \$1,112.45, the total amount approved for the First-Year Leadership Program (FYLP) to be \$106.795, the total amount approved for the Brazilian Student Association (BSA) to be \$479.434, the total amount approved for Humans vs. Zombies to be \$1,779.91, and the total amount approved for Gainesville Hillel to be \$3,222.52 by unanimous consent. Motion passes.

Chairman Rodriguez holds a discussion on Line 23 on Operational Budget Requests.

Khan moves to amend the programs total down to \$3,450 and amend the food total up to \$3,950 by unanimous consent. Motion passes.

Chairman Rodriquez adjourns the meeting at 6:01 PM.
