

**STUDENT SENATE BILL 2024-1534**

**TITLE: Resolution Calling for Unlocked Bathrooms in the Murphree Area**

**SPONSOR(S): Senator Gregory Nobleza**

**WHEREAS**, the Murphree Housing area consists of 5 residence halls with the capacity to house over 1000 students each year at the University of Florida [1]; and,

**WHEREAS**, the Murphree Area residence halls are traditional style dorms featuring communal bathrooms on each floor; and,

**WHEREAS**, other traditional style dorms, such as Rawlings, Trusler, and Honors Village have unlocked bathrooms within their residence halls; and,

**WHEREAS**, currently, the bathrooms within the Murphree Area residence halls are locked, requiring a key given to residents to enter; and,

**WHEREAS**, keys may be easily lost or misplaced, leading to students potentially locking themselves out of their rooms through misplacing their keys in the bathroom; and,

**WHEREAS**, students are provided with two free lockout services per semester, and are charged \$50 per incident after these free services are used [2]; and,

**WHEREAS**, an increased number of lockouts may put extra stress on students, both mentally and financially, while also placing extra responsibility on resident assistants to provide more lockout services; and,

**WHEREAS**, students will be moving into the Murphree Area residence halls between the dates of August 15th and August 17th, 2024 prior to the beginning of the Fall semester; then,

**THEREFORE, LET IT BE RESOLVED** that the University of Florida Student Senate recognizes the importance of accessible facilities for students living in on-campus residence halls; and,

**THEREFORE, LET IT FURTHER BE RESOLVED** that the University of Florida Student Senate recognizes that lockouts may cause students and resident assistants additional stress on top of their academic and personal lives; and,

**THEREFORE, LET IT FINALLY BE RESOLVED** that the University of Florida Student Senate calls for unlocked bathrooms within Murphree Area residence halls.
