## STUDENT SENATE BILL 2024-1541

TITLE: Resolution Advocating for Financially Accessible On-Campus Markets

WHEREAS, on June 1, 2022, Chartwells Higher Education became the main caterer and vendor of food for the University of Florida campus [1], and oversees both on-campus dining halls and convenience markets; and

WHEREAS, on-campus markets are important and necessary resources for students living on campus; and

WHEREAS, on-campus markets are a convenient source of food for students, allowing them to quickly purchase food between classes and outside of normal dining hall hours; and

WHEREAS, current item prices within on-campus markets are consistently higher than off-campus commercial alternatives; and

WHEREAS, prices within markets continue to rise, such as an increase to the price of many products in July of 2024, according to a personal interview with the Business Services Director of Administration and Finance; and

WHEREAS, the stated mission by Chartwells division president Nelson DeFigueiredo was to "align with UF's culture creating a program that celebrates the campus's rich history and supports our partners on campus" [1]; and

WHEREAS, current meal plans provide students with declining balance/flex bucks, along with \$7.25/day in retail equivalency which can be used in pod markets [2]; and

WHEREAS, despite these provisions to allow economic flexibility for students, the prices of said meal plans are contractually set to rise by 4.5% this year, and by 2.35% every subsequent year for the next 10 years; and

WHEREAS, the price increases for meal plans may create a higher barrier-to-entry to the bonuses they provide; and

WHEREAS, price increases within both meal plans and on-campus markets place increased stress on students financially; and

WHEREAS, the University's oversight over on-campus market prices could allow these markets to provide more affordable options for students; and

WHEREAS, retail equivalency offered within meal plans is meant to be the value of an entire meal; and

WHEREAS, there currently exists no established deal in an on-campus market where students may exchange \$7.25 for a sandwich/main, drink, and side; and

WHEREAS, the guaranteed provision of one such deal or bundle within markets could alleviate some financial stress and offset high prices for students both with and without meal plans; and

WHEREAS, there currently exists a Food Service Advisory Committee whose role is to advocate for student and administrative wants and needs as they apply to dining on campus; then,

**THEREFORE, LET IT BE RESOLVED** that the University of Florida Student Senate expresses concern for the high prices and price-raising practices within on-campus markets, and the potential impact of these prices on lower-income students.

**THEREFORE, LET IT FURTHER BE RESOLVED** that the University of Florida Student Senate stresses the importance of providing affordable and nutritionally complete eating options within on-campus markets in the interest of student health and wellbeing.

**THEREFORE, LET IT FURTHER BE RESOLVED** that the University of Florida Student Senate requests for Chartwells to provide a 'retail equivalency deal' in which a sandwich, drink, and side may be purchased for \$7.25 in on-campus markets, with available substitutions supplied for dietary restrictions.

**THEREFORE, LET IT FINALLY BE RESOLVED** that the University of Florida Student Senate urges administration, Chartwells, and the Food Service Advisory Committee to improve and maintain communication between each other and the student body.
