SSB 2024-1717 is under consideration.

Senator Britton Objects.

- Senator Britton moves to amend SSB 2024 - 1718 to only include current senators and change the last therefore clause to “the University of Florida Student senate supports listed endeavors..” by unanimous consent. Passed.
- Senator Bravo moves to Strike Chief Barganer Patrick Keegan from Proviso. Senator Britton Objects.
- Senator Britton moves to pass SSB 2024 - 1718 by unanimous consent. Passed.
