- A. Updates
 - a. Jacob Schneider loves Canva presentation, will prob happen
 - b. Wants medical amnesty to have its own slide
 - c. Map of safe places to ride scooters and parking

- j. After presentation: open discussion
 - Utilize/ leverage TAPS and UFPD, using their knowledge to our advantage (UFPD first)
 - 1. Ask "is 128 crashes since 2018 a lot?"; "typically speed tables reduce traffic related incidents by x%, do you think this infrastructure would improve safety in a similar way on Hull Rd?"; "Would a speed table on Hull Rd be a cost effective way to monitor traffic safety on Hull Rd?" (more than placing an officer on Hull Rd); "With speed tables in other areas on campus, have you seen a reasonable shift in speeding and crash percentages in those areas?"; "Would a speed bump hurt ambulances and EMS?";
 - ii. Captain Trevor Henderson said no specifics on data for crashes on Hull Rd (vehicle, where, when)
 - 1. Henderson very supportive and looks forward to meeting
 - 2. Ask about what is considered campus (more campus focused), ask if a speed bump would hurt buses or transportation efficiency?.
 - iii. Director Dixon Questions:
 - Ask about infrastructure and logistics for building infrastructure for Hull Rd
 - iv. Jeremiah Mckinnis (TAPS usually not responsible but happy to advise) participated in other safety related meetings
 - v. Jacob Schneider Nightlife Navigators possible drop in to meeting, add to presentation?
