Legislative History

The Senate Executive Officers of Spring 2025 hereby recommend that the University of Florida Student Senate establishes an Ad Hoc Committee to conduct a holistic review of these Rules and Procedures every five years, at minimum.

The Rules and Procedures was initially adopted by the Student Senate in 2008 (Resolution 2008-124). In 2011, the Student Senate subsequently amended the entirety of the Rules and Procedures to refine their scope and applicability (Authorization 2011-116). During the Fall 2013 term, Senate President Cory Yeffet charged an Ad Hoc Committee on Rules and Procedures, chaired by Susan Webster, to review and revise the entirety of this document. During the Spring 2025 term, Senate President Julia Seifer and Senate President Pro Tempore Aaron Rubaii revised and reconstructed the entirety of these Rules and Procedures to ensure their relevance within the modern context of campus life and Student Government (Authorization 2025-XXX).

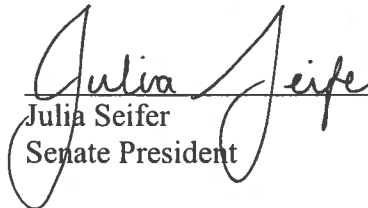
