~~CHAPTER 313 — SENATORIAL MEMBER ORGANIZATIONS ACT (2023-141, 2025-101, 2025-123)~~

~~313.001 — Officials of the Student Senate are permitted to form Senatorial Member Organizations (SMOs) consisting of fellow members representing a specific identity group or sharing a common legislative agenda. An SMO must maintain at least 4 members.~~

~~313.002 — Members of an SMO may determine the structure, leadership, and function of their SMO so long as such structure does not interfere with the Student Body Constitution, Senate Rules and Procedures, or other bylaws herein.~~

~~313.010 — Upon the agreement of the structure, leadership, and function of an SMO, the leader, or their designee, shall contact the Senate President with the SMO's membership and leadership makeup.~~

~~313.011 — SMO leadership must reaffirm that SMO's existence following the validation of each Fall and Spring Election via email to the Senate President.~~

~~313.012 — Student Government Advising and Operations shall update the Student Senate Roster website to accurately display a member's SMO affiliation upon request by that Senator.~~

~~313.020 — SMOs do not share the same privileges as Political Parties as outlined in Rule XVII of the Senate Rules and Procedures, as such, they shall not receive representation on the Replacement and Agenda Standing Committee of the Senate, nor enjoy any other right guaranteed to Political Parties in the bylaws herein.~~

~~313.030 — Senatorial Membership Organizations may otherwise be known informally as Caucuses of the Student Senate.~~
