STUDENT SENATE BILL 2026-1090

TITLE: Resolution Recognizing the Partnership Supporting the Honors Village RecRe Locker Initiative

WHEREAS, the University of Florida Student Senate supports initiatives that promote student wellness, recreation, and community engagement through responsible investment in programs and infrastructure that benefit the student body; and,

WHEREAS, Honors Village houses hundreds of University of Florida students and currently lacks nearby access to recreational equipment, requiring residents to travel to the Reitz Union or Flavet Field to check out equipment; and,

WHEREAS, the University of Florida Student Senate approved funding for the installation of a RecRe Locker at Honors Village to provide students with convenient access to volleyballs, footballs, soccer balls, Spikeball sets, frisbees, speakers, portable chargers, and other recreational equipment to encourage active lifestyles and strengthen residential community engagement; and,

WHEREAS, RecRe Lockers have already proven successful across campus, with the Reitz Union location recording more than 4,400 rentals and 24,000 hours of equipment use, while the Flavet Field locations have supported nearly 4,300 rentals, demonstrating a clear demand for accessible recreational resources [1]; and,

WHEREAS, the partnership between Student Government, Housing & Residence Life, and RecRe exemplifies the value of collaboration between student leaders and University departments in creating meaningful improvements to campus life; then,

THEREFORE, LET IT BE RESOLVED that the University of Florida Student Senate formally recognizes and expresses its sincere appreciation to Housing & Residence Life and RecRe for their partnership and commitment to the implementation of the Honors Village RecRe Locker initiative.

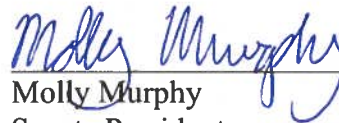
